## Instructor Presentations

**Rule 500 Trivia Bowl:** Jeff Force will review the document that governs the Acts Allowed for all EMTs. There are some new skills and pharmaceuticals you need to know about. This lecture will test your knowledge of current and new materials.

**Complex Delivery & Neonatal Resuscitation:** Is delivering a baby your worst nightmare? Dr. Meg Prado will attempt to mitigate your fears and even make you look forward to this beautiful event. She will look at the issue when things go right and when trouble occurs.

**Neurological Trauma:** A knock to the head can really make assessment difficult. Review the issues surrounding head trauma with Dr. John McVicker and learn some cutting edge information to help on your next call.

**Assisting ALS Providers:** Mark Goldstein returns with his unique perspective from both sides of the emergency room door. What does the ALS provider want from you and what can I learn to make my care even better? Mark will lead you through this important aspect of patient care.

**Crime Scene Preservation:** Every call you respond to could be a crime scene. How can we help our partners in emergency services do their job? They need to preserve potential evidence but does that trump providing patient care? Laura Cochran is a veteran with the Colorado Springs Police Department who understands both sides of this issue.

## Hands on Scenarios

**Information About Skill Stations:** BLS equipment and basic information about the scenario will be provided to each group as they enter the station. Please consider the amount of preparation required to provide these stations and treat them seriously. Our goal is to provide a realistic scene for you to learn ways to react to stressful situations while in a controlled environment. Enjoy the opportunity!

**Airway Skills:** You can never get too much practice providing quality respirations. Take this opportunity to review equipment and skills to make the next call with airway issues less stressful.

**Are we really supposed to ride those things?** If we were meant to ride horses, they would come with air bags...right? Your patient is still in the corral and unresponsive. Can I trust this horse? Let's find out together.

**Your Worst Nightmare...In a controlled scenario:** You say the baby's crowning?...What do mean it's a leg?! Work with your peers to deliver the baby and practice your resuscitation skills.

**ALS Assist Skills:** Whether you rendezvous with an ALS intercept, a helicopter flight crew, or help out in the emergency room, this skill station will help to make the patient handoff go smoothly.

Brian Keys returns with another exercise to test your skills. Multiple victims, injuries, and responding agencies always make this a unique experience.

**Bariatric Patient Handling Skills:** Our patients continue to get larger and they aren't homebound any more. This skill station is designed to test your ability to assess, treat, and transport these patients in a variety of situations.

**De-escalating Skills:** Many emergency situations have the possibility of spiraling out of control. Emotional family members, inexperienced providers, and other situations can arise. Are you able to talk your way through this scene?
