Program Positions, Roles, Responsibilities and Deliverables

I. Introduction:

Medical oversight, which includes protocol development and maintenance, education and training and CQI, begins at the agency level. As defined in Section 4 Medical Director Qualifications and Duties of the Department of Health CHAPTER TWO – EMS PRACTICE AND MEDICAL DIRECTOR OVERSIGHT RULES, EMS agency medical directors are responsible for developing and maintaining medical oversight programs for their agencies that ensure the competency of their EMTs and paramedics.

In order to assist the more than 100 EMS Agency Medical Directors in the State of Colorado, who provide their services to ensure that quality EMS is available throughout Colorado, a regional medical direction program to provide the resources necessary to help EMS agency medical directors better do their job was created. **This program is meant to be a resource for agency medical directors and is not meant, in any way, to interfere with the relationship between any agency medical director and their EMS agencies nor is it in any way meant to supplant the authority of the agency medical director. In addition, agency participation is voluntary. The resources will be made available to assist agency medical directors in providing medical oversight but each agency medical director will have the option to choose whether or not they want to utilize this resource. Whether an agency chooses to use this resource or not will not alter the agency medical director's responsibilities of providing appropriate medical oversight and ensuring competency of the providers working under their license, as defined in the Chapter Two EMS Rules.**

The purpose of the Regional Medical Direction (RMD) Program is to facilitate a statewide coordinated process of EMS medical oversight. Because the RETACs are responsible for coordination of statewide EMS activities, the RMD Program, whenever possible, should be developed as a partnership between the RETAC and the RMD Program. Typically, the RETAC coordinators are an integral part of the development and maintenance of the RMD programs, as they are normally involved in developing the proposals for funding, the scope of work and deliverables, hiring the RMD Coordinator, completing administrative tasks, coordinating the RMD program with other EMS programs within the RETAC including education, regional CQI and MCI programs, just to name a few.

Regional medical direction programs should be designed to

1. Facilitate peer communication and cooperation
 - a. Share ideas and practice concepts
 - b. Provide updates and facilitate discussion regarding
 - i. Chapter Two Rule Changes
 - ii. Advances in EMS clinical practice
 - iii. New developments in technology

- c. Discuss local and regional systems issues
2. Provide resources to EMS agency medical directors which will enhance their ability to perform their job functions as agency medical director

3. Facilitate regional CQI activities
 - a. Provides benchmarks against which agencies can evaluate their own status
 - b. Develop regional CQI questions that are of interest to the region
 - c. Discuss global data to determine opportunities for system improvement
4. Promote regional standardization
 - a. Standardize protocols
 - b. Standardize education and training
5. Facilitate communications between agencies and the state office
6. Facilitate communications between agencies and the healthcare community at large

II. Regional Medical Direction Program Positions:

1. Regional Medical Director / Regional Medical Direction Program Liaison

A. Qualifications:

- Physician who holds an active Colorado medical license
- Active involvement in EMS in the region
- Working knowledge of the CDPHE Chapter Two Rules
- Knowledge and experience in EMS medical oversight

B. Roles and Responsibilities

- Act as the liaison and promote communication amongst agency medical directors within the region
- Actively participate with regional EMS activities
- Organize and chair regular Regional Medical Directors Council meetings.
- Act as the liaison between the State EMTS Section and agency medical directors within the region
- Attend EMPAC Regional Medical Directors Council Meetings; Provide communication (bidirectional) between region and EMPAC
- Assist agency medical directors and agency CQI coordinators in establishing a medical continuous quality improvement program for each EMS service agency. The continuous quality improvement program must assure the continuing competency of the performance of that agency's Department-certified EMTs. This medical continuous quality improvement program shall include, but not necessarily be limited to, developing and maintaining assessment and treatment protocols, provision for medical care audits, observation, critiques, primary and continuing medical education and direct supervisory communications.
- Assist in the development of a regional CQI program.
- Assist the region in its participation in the statewide CQI program
- Assist in the development and maintenance of regional and / or local protocols.
- Participate in and assist with the implementation and monitoring of the regional trauma triage algorithm guidelines.
- Participate in Continuing Education outreach efforts. Partner with facility EMS Coordinators in providing CE to the rural areas

- Act as interim medical director for local EMS agencies, when requested, in the event of absence of the agency medical director due to emergencies, vacancies or temporary absences of their primary medical director.

2. Regional Medical Direction Program Coordinator

A. Qualifications:

- EMS provider who holds an active Colorado license with CDPHE
- Active involvement in EMS in the region (May need to better define)
- Working knowledge of the CDPHE Chapter Two Rules
- Knowledge and experience in EMS medical oversight

B. Roles and Responsibilities

Under the direction of the Regional Medical Director

- Acts as the liaison and promote communication amongst EMS agencies within the region
- Active involvement with regional EMS activities (May need to better define)
- Assist the Regional Medical Director in preparation for Medical Directors Council meetings.
- Act as the liaison between the State EMTS Section and agencies within the region in regards to medical oversight activities
- Attend EMPAC Regional Medical Directors Council Meetings
- Assist agency medical directors and agency CQI coordinators in establishing a medical continuous quality improvement program for each EMS service agency. The continuous quality improvement program must assure the continuing competency of the performance of that agency's Department-certified EMTs. This medical continuous quality improvement program shall include, but not necessarily be limited to, developing and maintaining assessment and treatment protocols, provision for medical care audits, observation, critiques, primary and continuing medical education and direct supervisory communications.
- Assist in the development of a regional CQI program.
- Assist the region in its participation in the statewide CQI program
- Assist in the development and maintenance of regional and / or local protocols.

III. Deliverables:

- a. Tools to facilitate communication amongst EMS agency medical directors throughout the region and to promote EMS education of agency medical directors
 - i. **Regional Medical Direction Meetings**
Set up regularly scheduled meetings that will facilitate communication between agency medical directors. The meetings should occur, at a minimum, once yearly. Optimally, more frequent meetings should be considered.
 - ii. **Regional Medical Direction Newsletter**
Develop a newsletter to communicate important EMS happenings, educational offerings, changes in scope of practice, updates on clinical practice concepts and new developments in technology. Make the newsletter available through the RETAC web site or other appropriate venues
 - iii. **Web-based communication of regional happenings**
 - 1. Regional Training and Educational Offerings
 - 2. Summary of happenings at the state
 - 3. Update on EMPAC
- b. **Promote regional standardization**
 - i. Develop / adopt a regional set of protocols
 - ii. Regionalize education and training. Promote discussion / participation amongst agency medical directors to improve efficiency in the delivery of education and training
- c. **Facilitate CQI activities**
 - i. Acts as a resource for CQI education to agency CQI coordinators
 - ii. Promote discussion amongst agency medical directors on development and maintenance of a regional CQI program
 - iii. Act as a resource that facilitates EMS agencies ability to submit "clean" data to the state
 - iv. Provide benchmarks (from State data) against which agencies can evaluate their own status
 - v. Develop regional CQI questions that are of interest to the region
 - vi. Discuss global data to determine opportunities for system improvement
